1) What data do we collect?

We collects the following data:

- Personal identification information (Name, email address, phone number, etc.)
- 2) How do we collect your data?

You directly provide us with most of the data we collect. We collect data and process data when you:

3) How will we use your data?

5) What are your data protection rights?

The right to object to processing - You have the right to object us for the processing of your personal data, under certain conditions.

The right to data portability - You have the right to request us to transfer the data that we have collected to another organization, or directly to you, under certain conditions.

Cookies are text files placed on your computer to collect standard Internet log information and visitor behavior information. When you visit our websites, we may collect information from you automatically through cookies or similar technology.
